Residents refers to those people that lived in the Parish of Aston Clinton immediately prior to their death or who lived in the parish and moved into a nursing home or hospice less than 24 months before their death.

Exclusive Right of Burial (EROB) ownership of the EROB enables the Grantee to decide who should be buried in the grave, subject to the availability of sufficient space in the grave.

Unless it is the burial of the Grantee, no burial may take place in the grave without the written consent of the Grantee.

No memorial may be placed on the grave without the written consent of the Grantee.

Ownership of the EROB does not grant ownership of the land itself, which remains in the ownership of Aston Clinton Parish Council.

Children's Funeral Fund (CCF)

Please note that if the child is aged between 24 weeks gestation and 18 years parents are entitled to the services listed below on a free of charge basis via the <u>Government Children's Funeral Fund.</u>

- * burial fees
- * cremation fees, including the cost of a doctor's certificate
- * coffin, shroud or casket (up to a cost of £300)
