P21.105 Questions and Comments from the Public.

A member of the public provided the committee with information regarding application 21/04930/APP: 68 Long Plough.

A member of the public raised concerns regarding the landscaping at the Aston Brook Bovis development. The hedging was not the correct height and there were gaps, the fencing was incomplete, and the footpath had not been completed. The member of the public agreed to share photos and a landscaping report.

P21.110 To Report on Current Active Medium to Large Scale Development Sites

Chapel Drive: Cllr Read reported that all the footpaths were open, and hedges planted.

Aylesbury Road Shanly Homes Development: It was noted that the developers and Bucks Council's enforcement team had been contacted regarding the failure of the developers to adhere to the traffic management plan for the site. The enforcement team had confirmed that they would investigate the matter. The developers had not responded.

Ground mounted solar farm with DNO substation, point of connection, ancillary infrastructure and associated works, landscape planting and access tracks.

RESOLVED: OBJECT to the amended planning application and support the comments made by Hulcott Parish Council in that Aston Clinton Parish Council would not object to a smaller proposal, confined to the southern section, the northern section being too intrusive, affecting historical features, visual amenity and quality of life.

P21.112 To Consider a Response to a Resident's Complaint Regarding Seven Acre Farm.

The soil bank at the farm, which had screened much of the activity on the site, had been removed. This meant that the HGVs on the farm were within full sight of Aylesbury Road and its residents causing both light and noise pollution. Residents would like some form of screening reinstated.

It was also noted that bright lights had been installed on existing farm building which were on throughout the night and could be clearly seen from neighbouring properties causing light pollution.

The committee would review the conditions for the approved planning applications for the site. If the planning conditions have not been met especially regarding landscaping planning enforcement would be informed. Cllr Wyatt and Cllr Mason would also visit the site.
